#### **OLD BUSINESS**

Chairman Martin asked if there was any old business. Commissioner Frisch wanted to mention the loss of life in the line of duty for the firefighter in the Rockland county fire at the assisted living facility.

#### **NEW BUSINESS**

Chairman Martin reported that Middlesex county is allowing us to use their voting machines. Chairman Martine attended training and he will man the voting machine the night of the election. They are providing 2 machines, but only may be used. It will still require obtaining signatures from voters, using digital voter registrations books. The county provided alcohol wipes to clean the touch screen. There will be no need to count ballots, since the machine prints out results. Will not use poll workers to keep it safe. There is a vote by mail drop box in town. Those will need to be counted as well. The county will provide any preliminary votes. The voting machines will be delivered tomorrow, 4/15.

#### **CHIEF'S REPORT**

Chairman Martin asked for a report from Fire Prevention.

Chief Carbin reported:

- Annual accumulation of hours for career staff
- Career training will begin in April
- Reviewed Incident Run log 85 for the month
- Top responder was FF Alok, followed closely by FF Awad
- Met with Township Business Administrator regarding switch to county radio system in June.
   We are in the best position for radios to switch. Chief doesn't believe the switch will occur June 1st. If our budget passes, we can purchase 90% of radios on our own.
- Pump training will begin once the weather is warmer
- There are purchases needed, but will wait until after election.

April 14, 2021 Meeting

 The new shifts were assigned, and they will take place May 15. Chief will email it to the Commissioners.

#### **VOLUNTEER FIRE COMPANY REPORT**

Chairman Martin asked for a report from the volunteers.

Firefighter Awad asked for an update on the hard suction requested last July. Chief reported that he was told it has a ship date of May 15th.

The volunteers also have another driver at the station, which makes 4 drivers, and more are interested. The volunteers would also like to have an AED on their engine. Chief Carbin stated that once we get past the election, we can look at purchasing one. The cost is \$7200.

## **MEETING OPEN TO THE PUBLIC**

Chairman Martin mentioned next month's commissioner meeting will be in person at the firehouse.
