

Minutes of the Regular Meeting Wednesday, October 9, 2024

The Monroe Township Board of Fire Commissioners of District No. 2 met at the Monroe Township Fire District #2 & EMS building, 10 Halsey Reed Road, Monroe Township, New Jersey for the Regular Meeting.

Chairman Martin called the meeting to order with a Salute to the Flag at 7:00 pm. Chairman Martin asked for a moment of silence for all firefighters, EMS, police, and military, who have died in the performance of their duties.

OLD BUSINESS

Chairman Martin asked if there is any old business that needed to be discussed, there was none.

FIRE PREVENTION BUREAU REPORT

Chairman Martin asked for the Fire Prevention Report. Chief Volkmann electronically submitted the calls of interest and fire prevention breakdown and reported on the following:

- Smoke certifications are ahead from last year at the same time
- Training
 - o Live burn with District 3 at Middlesex Fire Academy
 - o All shifts have been trained on new air packs
 - Four people were certified as "Train the Trainers"
 - o Fit testing has begun. Additional larger size masks are needed
 - o Volunteers have been working on car extraction and hose packing
- For the first time in four years, the department went back into Applegarth and Oak Tree schools for fire prevention with the students. Firefighter Chancy did an amazing job putting the entire event together. A thank you letter was received form Dawn Graziano, Applegarth School Principal.
- Chief Volkmann will be in training this week at Middlesex County Academy

COORESPONDENCE

Chairman Martin asked if there is any correspondence. County Fire Marshal sent an email asking career chiefs to participate in a task force to assist with research on Senior Fall Prevention. Chief Volkmann agreed to participate.

NEW BUSINESS

Chairman Martin asked if there is any new business.

Commissioner McGee discussed that the cement repairs are still not completed and he has not heard back from the township engineer yet. He has concerns that the weather is getting cooler and that the repairs need to be done prior to winter. Chief Volkmann noted that the contractor hasn't been paid yet.

Regular Meeting October 9, 2024

Commissioner McGee also noted that the light over one of the bays is out. The correct size has been ordered.

Commissioner McGee spoke with Chief Volkmann about an exterior door on the EMS side is not installed correctly and water is coming in and damaging the floor. In addition, there is an issue due to a gap underneath the flooring and water flowing under the threshold. Both issues need to be remediated.

Truck Update:

Chairman Martin received correspondence with both the county Board of Elections and state DCA to get a full understanding on the process that needs to be followed to purchase the tower ladder. The current estimate is \$2.5M.

A Special Meeting needs to be held to discuss the following:

- If no financing is needed, then capital can be used.
 - o Capital will be invested and earn between \$150K \$300K in the three years it will take for the truck to be built.
 - o In addition, each year (2024, 2025 & 2026) an estimated \$400K of budget surplus would be accrued totaling \$1.2M.
 - o Between those two actions, between \$1.2M \$1.5M of the \$2.5M would be replenished.
- If financing is needed, then it would require an election, resolution, posting and local financing board approval.
 - o 5-year lease/purchase would cost \$640K/year = \$700K of interest paid in total
 - o 10-year lease/purchase would cost \$366K/year = \$1.2M of interest paid in total

UPON MOTION MADE by Glenn Borsuk and seconded by Michael Frisch, to hold a special meeting on November 13, 2024 between 6pm – 9pm for regarding the purchase an aerial apparatus.
