OLD BUSINESS

Per Chairman Martin, the lighting project is complete. Initially, the plan was to pay the \$95,000 over five years, however since this is a municipality they would only finance \$75,000. The variance was paid and the balance will be paid over five years in the amount of \$1,250 per month to be auto-debited.

COORESPONDANCE

Chairman Martin read a correspondence received from Plainsboro Township which recognized the departments outstanding efforts at a recent fire.

Chairman Martin read a letter from Firefighter Hoffman stating that he plans to retire in November 2024. Best of luck to Firefighter Hoffman.

NEW BUSINESS

Chairman Martin discussed the process to purchase the new equipment once the final amount is received. Board Attorney Shaklee to confirm the steps.

Commissioner McGee announced that CPR training was held with Station 51 and an additional training is scheduled next month.

Chairman Martin asked that Board Attorney Shaklee review the legal language to determine which notices need to be published in the newspapers and which can be posted elsewhere.

FIRE PREVENTION BUREAU REPORT

Chairman Martin asked for the Fire Prevention Report.

Chief Volkmann reported on the following:

- Run log and fire prevention materials previously electronically distributed to Commissioners.
- Training report for the month of March
 - o Every Thursday RIT training is being performed at Station 23
 - o Live burn scheduled in May

- o Volunteers Firefighter survival entanglement training was completed using the prop
- o June extrication training scheduled in Howell Township. Volunteers to be invited
- CPR save of a 47-year-old male. The family has asked to come to the station to thank the crew
- Firefighter O'Brein completed all the paperwork and submitted for a \$40,000 grant for equipment from Firehouse Sub Corporation. If awarded, looking to purchase thermal imaging cameras
- 45 people registered for the written exam of which 42 passed 2 failed and 1 was a no show
 - Next week Wednesday Friday are the practice nights for the physical test. Actual test to be help on April 21st
- Fire Prevention clerk started in her new role at the firehouse. She will work Tuesday, Wednesday and Thursdays, 8 hours per day
