## Minutes of the Regular Meeting Wednesday, September 9, 2020

### **CHIEF'S REPORT**

Chairman Martin asked for a report from Fire Prevention.

## Chief Carbin reported:

- Inspections caught up except for 4 businesses, not open yet.
- Reviewed Incident Run log- 112 for the month.
- Services for 9/11 from Monroe Township included in the report.
- Promotion exam will be 10/17, oral interview 10/24; Top 6 candidates from written move to oral interview. Waiting for approval from school. If not approved, testing agency will need to provide another option.
- Replacement tanker and pickup truck proposed to do a public voting from 6pm-9pm at the October 14<sup>th</sup> regular meeting to appropriate the funds to put in the budget. Chief Carbin will draft the information so it can be advertised.
- Spoke with Chief of Police, he will continue to dispatch PD and EMS, due to COVID. Chief Carbin said if there is a CPR call in the area and no one is responding, FD will respond. Chief of Police will revisit proposal next year.
- Task Force 1 is a state deployed team that goes to Natural Disasters. FD#2 has a firefighter that would be paid/overtime by board, and the board would be reimbursed by the state. Length of time is 20 days, which will require covering shifts. Training that comes back is beneficial to department. The firefighter needs to let them know for the remainder of the year if he can stay on Task Force.

**UPON MOTION MADE** by Glenn Borsuk and seconded by Robert McGee, to allow Firefighter Chrepta to stay on Task Force 1 until 12/31/20, and re-evaluate for the 2021 year.

## **VOLUNTEER FIRE COMPANY REPORT**

Jennifer Awad stated the volunteers are starting to come to the firehouse, primarily during the storms. Finding that there have been occasions when the truck has not been at the volunteer house. Chief Carbin stated it was written on the side board when the truck was taken, but not noticed since it's a board volunteers don't use/view. Will know to look there going forward. In addition, requested whomever is driving the trucks should be trained on that truck (min 20 hours), and/or given a refresher.

### **NEW BUSINESS**

Chairman Martin mentioned the election is a topic to start thinking about. If you can't be done in person, it will be very expensive. Commissioner Tannenbaum stated you can vote in person. Commissioner Borsuk stated we can also control the number of people and distance to do in person voting. Chairman Martin wants to think how we can educate the public on the budget so when they receive the ballot, they understand what they are voting for.
